Ángel Vilá Boix is a member of the Supervisory Board of Telefónica Deutschland Holding AG since 26 March 2025.

From July 2017 until March 2025, Àngel Vilá was Chief Operating Officer (*Consejero Delegado*), member of the Board of Directors and of the Executive Committee of the Board at Telefónica, S.A.

He joined Telefónica, S.A. in 1997 and prior to being Group COO, has held positions of Group Chief Strategy and Finance Officer, Group Head of Corporate Development and CFO of Telefónica Internacional.

In his tenure, he has orchestrated material corporate transactions, including the acquisitions of O₂ and Vivo, IPOs (Telefónica Deutschland Holding AG), in-market consolidations (VM02 - UK, O₂/ EPlus - Germany, GVT and Oi - Brazil), infrastructure transactions (Telxius/American Tower, fibercos in UK, Germany, Spain, Brazil) and divestments (Telefónica Czech and Ireland, Telecom Italia, O2 Airwave- UK, Meditel Morocco), among others.

Prior to joining Telefónica, he held positions at Citigroup, McKinsey&Co, Ferrovial and Planeta.

In the financial sector, he has served on the Board of Directors of Banco Bilbao Vizcaya Argentaria (BBVA) and currently in the Board of Mediobanca SpA.

In the digital infrastructure sector, he has served on the Advisory Panel of Macquarie European Infrastructure funds (MEIF I, II and III).

In the TMT sector, he has been Chairman of TEF Contenidos, Vice Chairman of Telco SpA (Italy) and Board member of Telefónica Deutschland Holding AG, Telefónica Brasil, Endemol, Digital+, Atento, Telefónica Czech, CTC Chile, Indra SSI and Terra Lycos.

Among non-for-profit positions, Ángel Vilá served on the Board of Trustees of the Telefónica Foundation and of the Barcelona Mobile World Capital Foundation.

Institutional Investor nominated Angel Vilá as the Best CFO in European Telecoms in 2015. He was also honored with the Thomson Reuters Extel Pan-European Awards as No. 1 CFO in Spain both in 2013 and 2014 (all sectors), as well as No. 1 CFO for Telecoms in Europe in 2014.

Ángel Vilá holds a MBA from Columbia Business School where he studied with a Fulbright La Caixa fellowship. He was distinguished in the Beta Gamma Sigma Honor Society and the Dean's List. Prior to Columbia University, he graduated in Industrial Engineering from Universitat Politècnica de Catalunya in Barcelona.
